CGS 2B - Intro to CGS: Gender & Institutions

Karen Shelby, Critical Gender Studies Program
This course examines how gender organizes and is
organized by institutions. Domains of inquiry may include
family, education, medicine, technology, law, media, the
workplace, immigration, and citizenship.

CGS 111 – Gender & the Body

Karina Eileraas, Critical Gender Studies Program
Various approaches to the study of gendered bodies.
Possible topics to include masculinities/feminities;
lifecycles; biology, culture and identity; medical discourses and health issues. May be taken for credit three times when topics vary.

CGS 113 - Gender & Sexuality in the Arts

Karina Eileraas, Critical Gender Studies Program
Examines gender and sexuality in artistic practices: music, theater, dance, performance, visual arts, and new media.



Topics may include study of specific artists, historical moments, genres, cross-cultural analyses, and multiculturalism. May be taken for credit three times when content varies.

CGS 114 – Gender, Race, Ethnicity, & Class

Daphne Taylor-Garcia, Department of Ethnic Studies

(Cross-listed with ETHN 183) This seminar explores the relationship of race, class, and gender by examining the participation of working class women and youth of color in community politics and how they challenge mainstream political theory. Moving beyond the notion that these social categories merely represent "layers of oppression," we will ask: how are race, gender, and class co-constitutive in the making of social relations and identities in the US and beyond? In this course we will pay particular attention to the situation of people who have lived in housing projects. The full scope and complexity of housing project residents' lives are frozen into images and dehumanized in the popular imaginary. Thus, we will center the consciousness, perspectives, and agency of housing projects residents in our study of class, gender, and race to challenge prevalent stereotypes and to listen to their insights.
